The Logos School of Music and the Customer agree to the following:

1. The Customer agrees to rent the musical instrument described in the Schedule attached to this agreement, to be used solely by the student. The Customer agrees to the payment amounts and payment terms described in the Schedule attached to this agreement. The Logos School of Music maintains full ownership of the instrument during the period of this agreement.
2. This agreement shall be for the period of the school year. The instrument along with all accompanying accessories **will be given to the Customer only after the agreement is signed and payment is made.** The instrument along with all accompanying accessories **will be returned on or before the last day of the term** in the same condition it was received (except normal wear and tear). Early returns are prorated by quarter increments only.
3. Logos School of Music shall make the instrument available to the Customer for the inspection on the effective date, and upon taking possession of the instrument, the Customer shall acknowledge that the instrument is in good playable condition as described in the schedule; provided, however, that if the Customer is not satisfied with the condition of the instrument, **may return the instrument to the owner within 7 days from the effective date**, in the same condition. The owner shall replace the instrument with a similar one or shall refund the rental fee to the Customer and this agreement will be terminated.
4. The Customer agrees to keep the instrument in good working condition. Repairs and adjustments to the instrument, made necessary by normal use, will be made at no charge to the Customer. This agreement may be terminated by Logos School of Music if is determined that the instrument is being abused or used in negligent manner. **The Customer shall be responsible for the costs**
